**Terms & Conditions (Please read carefully):**

1. Tuition is payable in 10 equal monthly installments, due on the 15<sup>th</sup> day of each month from August through May. After a fifteen-day grace period, a finance charge of \$25 will be added to the account.
2. Registration and other fees are payable in full at the time of registration. Registration fees are non-refundable.
3. **All Payments shall be applied to the oldest balances, first.**
4. Dishonored checks shall incur a \$30.00 fee.
5. The School may withhold students from class, exams, and school activities if their tuition and fee payments are delinquent for more than 60 days.
6. Students with prior-year unpaid balances may be refused enrollment.
7. The School may turn over delinquent accounts for collection and to initiate legal action to collect past-due amounts owed.
8. Parent(s) shall provide the school with a photocopy of their S/S card and D/L for safekeeping.
